MONOLITH MUSIC FESTIVAL Giveaway
Official Rules

1. Eligibility. No purchase necessary to enter or win. MONOLITH MUSIC FESTIVAL Giveaway (“Sweepstakes”) is open to all U.S. residents, 13 years of age or older who have a MySpace account. Sweepstakes begins at 3:00pm Pacific Time on June 7, 2007 and ends on 11:59 p.m. Pacific Time on August 7th, 2007.
2. Sponsor. Sweepstakes is sponsored by AEG Live, LLC, 930 W. 7th Ave, Denver, CO 80204 (“Sponsor”) and not affiliated with, endorsed by, or sponsored by MySpace.com.
3. How to Enter. Access the MY CONCERTS DENVER MySpace page at <http://www.myspace.com/myconcertsdenver> (MY CONCERTS DENVER), and post a comment in the Blog titled “MONOLITH MUSIC FESTIVAL GIVEAWAY” indicating that you want to win the tickets, put MY CONCERTS DENVER in your top friends list and send a bulletin to your friends to visit the MY CONCERTS DENVER MySpace page. Only one entry per person. Persons with multiple MySpace accounts may enter only one time. Sending bulletin does not increase your chances of winning. Your posted comment must be received by 11:59 pm Pacific Time on the Concert Location Final Entry Date as listed below and it must indicate that you want to win the tickets. Entries received after the Final Entry date will be disqualified.
4. Selection of Winner: On the day of the concert, one entry will be randomly selected from among all eligible entries as the chosen winner (“Selected Entrant”) for the concert tickets (“Prize”). Selected Entrants must respond within 4 hours from being contacted on their MySpace page in order to receive the Prize. If Selected Entrant is under 18 years of age, he or she must have a parent or guardian complete a declaration of eligibility and liability release form that will be sent to them. Due to time constraints any Selected Entrant who does not respond as instructed within the time frame, will be disqualified and another entrant will be chosen. Prize will be made available at The MY CONCERTS DENVER’s Will Call area. Valid identification will be required to claim Prize at Will Call.
5. Concert Dates
September 14th & 15th, 2007 – Red Rocks Amphitheatre – Morrison, CO (Final Entry Date is August 7, 2007)
6. Prize: Two 2-Day concert tickets, good for entry by two people, to see MONOLITH MUSIC FESTIVAL at Red Rocks Amphitheatre on September 14th and 15th, 2007 and 2 VIP wristbands for each day (sorry, no substitutions or transfer of Prize). Approximate retail value for the pair of tickets and VIP wristbands is \$160.00. In the event that Sponsor cannot award the Prize, one of equal or greater value will be awarded. Prize is not redeemable for cash except at the discretion of Sponsor. Prize is limited to those items listed here. Travel and other expenses are the sole responsibility of Selected Entrant.

7. Cancellation or Suspension: If for any reason the Sweepstakes is not capable of running as planned, including, but not limited to, unplanned or planned outage of MySpace site, infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failure or other causes that corrupt or affect the administration, security, fairness, integrity or proper conduct of the Sweepstakes, Sponsor reserves the right, at their sole discretion, to cancel, terminate, modify and/or suspend the Sweepstakes and, if terminated or cancelled, to determine potential winners in a random drawing from among all eligible entries received prior to the action taken; and to disqualify any individuals who tamper with the entry process, violate these Official Rules, or act in a disruptive or abusive manner.
8. Conditions: All decisions of Sponsor are final and binding; and entrants agree to waive any right to claim ambiguity in the Sweepstakes or these Official Rules, except where prohibited by law. By accepting a Prize, winner agrees to release Sponsor, MONOLITH MUSIC FESTIVAL, its attorneys, affiliates, together with the respective directors, employees, officers, licensees, licensors and agents of each, including without limitation, their respective advertising and promotion entities and any person or entity associated with the production, judging, or administration of the Sweepstakes, (collectively, the "Releasees") from any and all liability, loss or damage arising from or in connection with awarding, receipt and/or use or misuse of Prize or participation in any Prize-related activities. Winners acknowledge that Sponsor is not responsible for his/her safety at a concert environment and assumes all risks associated with attending a live public event. Sponsor reserves the right to use the Sweepstakes for publicity purposes in any media, and to use the name, likeness, and hometown name and/or Prize information of selected entrants as part of that publicity, without any compensation or prior review unless prohibited by law. Any such use with respect to minors shall be subject to prior approval of parent or legal guardian. Taxes, if any, are the sole responsibility of selected entrants, and selected entrants who are U.S. residents may be issued an IRS Form 1099 for the ARV of any awarded Prize. This Sweepstakes is void outside the U.S. and where prohibited or restricted by law, and subject to applicable federal, state, provincial and local laws. Sponsor reserves the right to disqualify any entrant it finds to be tampering with the entry process or the operation of the Sweepstakes or violating these Official Rules. The Releasees shall not be liable for computer malfunctions, lost connections, disconnections, delays or transmission errors; data corruption, theft, destruction, unauthorized access to or alteration of entry or other materials; any injuries, losses or damages of any kind caused by the Prize or resulting from acceptance, possession or use of a Prize, or from participation in the Sweepstakes; or (v) any printing, typographical, administrative or technological errors in any materials associated with the Sweepstakes. Sponsor disclaims any liability for damage to any computer system resulting from participating in, or accessing or downloading information in connection with this Sweepstakes. Sponsor may prohibit an entrant from participating in the Sweepstakes or winning a Prize if, in its sole discretion, it determines such entrant is attempting to undermine the legitimate operation of the Sweepstakes in any way by cheating, hacking,

deception, or any other unfair playing practices of intending to annoy, abuse, threaten or harass any other players or Sponsor representatives. Use of any automated system to participate is strictly prohibited and will result in disqualification. Sponsor may disqualify at its sole discretion any entries it believes are created by an automated system. Sponsor may disqualify at its sole discretion any entries it believes exceed the maximum number of entries. Disputes regarding these Official Rules and/or this Sweepstakes will be governed by the internal laws of the State of California. Any and all legal actions or claims arising in connection with this Sweepstakes must be brought in a court of competent jurisdiction within the United States.
